RE: MANAGEMENT OF CAULERPA TAXIFOLIA OUTBREAK

1. PROPOSAL

To seek Cabinet approval to amend the Harbors & Navigation (Control of Caulerpa Taxifolia) Regulations 2002 under the Harbours & Navigation Act 1993 to extend the current quarantine of West Lakes as part of the management of the Caulerpa taxifolia outbreak to 30 June 2002.

2. BACKGROUND

- 2.1 An exotic seaweed was found in West Lakes on 18 March 2002 by a research officer from SARDI Aquatic Sciences, and it was later identified as the invasive marine pest plant *Caulerpa taxifolia*.
- 2.2 Surveys by SARDI and the Marine Habitat Program have found that Caulerpa taxifolia has spread throughout the West Lakes system, and to the upper Port River
- 2.3 Cabinet on 8 April 2002 approved the drafting of the *Harbors & Navigation* (Control of Caulerpa Taxifolia) Regulations 2002 to quarantine the Lake by banning all aquatic activities. The regulations carried an expiry date of 9 May 2002, as this was thought to be sufficient time for investigations to recommend a further course of action to Cabinet.
- 2.4 By use of the exemption power in the *Harbors & Navigation 1993* the Director of Fisheries under delegation has issued exemptions to a number of user groups based on a risk assessment analysis, and on conditions including strict protocols for prevention of spreading Caulerpa.
- 2.5 Fishing activities have been banned in West Lakes and the upper Port River under the Fisheries Act 1982 since 28 March 2002 and it is intended to also extend this ban indefinitely as part of the package of restrictions.

3. DISCUSSION

- 3.1 The presence of this species in the West Lakes area poses a significant risk for South Australia and a threat to bio-diversity and fisheries production in this State.
- 3.2 **U**rgent scientific assessment by SARDI Aquatic Sciences is ongoing, including the trialing of a number of treatment options for eradication of Caulerpa from West Lakes and the upper Port River.

- 3.3 It is not expected that the results of those trials and a decision to take action on an option will be achieved before mid June, therefore the prudent course of action is to extend the closure until 30 June 2002, so as not to prejudice the treatment options by increasing the risk of spread of Caulerpa if the ban was lifted.
- 3.4 In addition, all of the 5 potential treatment options except one are likely to result in the total closure of West Lakes in June.
- 3.5 All of the existing exemptions will be re-issued on amendment of the Regulations and more may be able to be granted as compliance within the community has been excellent so far. If however the treatment options chosen result in the total closure of West Lakes, all exemptions will need to be revoked.
- 3.6 A meeting of major stakeholder groups including Charles **S**turt Councillors is scheduled for Thursday evening 9 May to discuss the extension to the restrictions and possible eradication options.
- 3.7 Parliamentary Counsel has completed settled regulations as attached.

Timing

3.8 Urgent, as current regulations are only effective to midnight on 9 May 2002.

3.9 Nil.

State development, social, environmental and family impact

3.10 Extending the closure of West Lakes to all aquatic activity will continue to impact on recreational activities as will the potential impact of the weed on the marine environment. However, in line with the risk assessment exercise, exemptions will be granted to user groups under certain conditions.

3.12 Consultation has occurred with the relevant Government agencies involved in the Emergency Management Response team, including the City of Charles Sturt.

Executive Council

3.13 The Regulations will require submission to Executive Council after Cabinet approval.
