Legislation

South Australian Multicultural Commission

Commission members were initially appointed for a three-year period under the South Australian Multicultural and Ethnic Affairs Commission (SAMEAC) Act (1980). On 2 December 2021, a new Act, the South Australian Multicultural Act 2021, came into operation. Among other purposes, the new Act replaced the former SAMEAC with the South Australian Multicultural Commission (SAMC). Former SAMEAC members were transferred to SAMC under a transitional clause in the new legislation.

South Australian Multicultural Act 2021

An Act to advance multiculturalism and interculturalism in South Australia, to establish the South Australian Multicultural Commission, to provide for the South Australian Multicultural Charter, to repeal the South Australian Multicultural and Ethnic Affairs Commission Act 1980, and for other purposes.

Multicultural Chambers of Commerce Group networking events

The newly established Multicultural Chambers of Commerce Group is a collection of small chambers of commerce in South Australia who represent global connections and business interests, with a focus on opportunities in import and export markets.

Commission members attended the Chambers of Commerce networking event on 28 February 2023 which was co-hosted by the Minister for Multicultural Affairs and Business SA. A presentation on tourism investment opportunities was delivered by Ms Emma Terry, Chief Executive Officer, South Australian Tourism Commission.

South Australian Multicultural Charter

Members of the South Australian Multicultural Commission supported and contributed to the development of the South Australian Multicultural Charter, through leading and participation in engagement and consultation forums and working groups.

Representing the Commission on the Charter Working Group was Commission Chair, Ms Adriana Christopoulos, as well as fellow Commission members Ms Carmen Garcia, Mr Rajendra Pandey and Ms Khuyên (Quin) Trần.

Commission members, Ms Anna Cheung, Ms Manju Khadka, Mr Rajendra Pandey, Ms Shaza Ravaji and Ms Khuyên (Quin) Trần lead a series of public consultation forums with the support of Multicultural Affairs, DPC.

Under the provision of the *South Australian Multicultural Act 2021*, Commission members have an ongoing role in promoting the Charter and the advantages of a multicultural and intercultural society.

Governor's Multicultural Awards

The Commission once again supported and promoted the annual Governor's Multicultural Awards in 2022-23. These important awards recognise and celebrate South Australians who promote multiculturalism and increase the understanding of the benefits of cultural diversity in our community.

An independent panel of judges chaired by His Honour Judge Rauf Soulio AM assessed the nominations and determined the finalists and winners of the 2022 Governor's Multicultural Awards. The judging panel also included Commission Chair, Ms Adriana Christopoulos, and Commission member, Mr Ahmed Zreika.

Her Excellency the Hon Frances Adamson AC, Governor of South Australia, announced the winners of the 2022 Governor's Multicultural Awards at a ceremony at Government House on Thursday 9 March 2023. The Commission members were invited to attend. Nine award recipients were chosen from 21 finalists across nine award categories.

Policing for a Multicultural Society Awards

The Policing for a Multicultural Society Award was initiated by the Commission in 2009. The award is presented to the police cadet in each graduating recruit course who shows the highest level of appreciation and understanding of migrant, refugee and cultural diversity issues relating to policing.
