Freedom of information application

I refer to your request received by the Department of the Premier and Cabinet (DPC) seeking access under section 13 of the *Freedom of Information Act 1991* (the Act) to:

Total cost and a breakdown of all expenditure including a copy of all receipts, invoices and reimbursements for the event to celebrate the announcement of the Australian Space Agency (ASA) headquartered in Adelaide on 17 December 2018.

Under the Act, an agency has 30 days to respond to a freedom of information request. As DPC did not respond to your request within the time frame required, the Department is deemed to have refused you access to all documents relevant to your application. However, I have determined to process the request as if the statutory time frame had been met.

One document was discovered as answering the terms of your request and I have determined to release this document in part. The document relates to the production of a banner, which was the only expense incurred by DPC in relation to the event. The logistics and main expenses relating to the event were organised and incurred by Defence SA.

This document contains account numbers which form part of the business and financial affairs of a third party. These account numbers are likely still active. If released there is a possibility some adverse effect could flow from their disclosure. It is my view that a claim for exemption of the account numbers under clause 7(1)(c) is therefore justified.

Exemption

Clause 7 – Documents affecting business affairs

(1) *A document is an exempt document—*

...

(c) *if it contains matter—*

(i) *consisting of information (other than trade secrets or information referred to in paragraph (b)) concerning the business, professional, commercial or financial affairs of any agency or any other person; and*

(ii) *the disclosure of which—*

(A) *could reasonably be expected to have an adverse effect on those affairs or to prejudice the future supply of such information to the Government or to an agency; and*

(B) *would, on balance, be contrary to the public interest.*


Right to internal review
