# Appointments to Boards and Committees: What goes to Cabinet?

Board and committee appointments are referred to Cabinet in the following circumstances:

- Its members are appointed by the Governor
- It is a public corporation or significant statutory authority (or the governing body of either)
- It is a major advisory body
- Its members receive annual remuneration.

Appointments to boards are dealt with in two ways, using the [Cabinet Submission – Appointments](#) template available on the [DPC website](#):

- For boards to which appointments are made by the Governor, appointments must be approved by Cabinet before proceeding to Executive Council, or
- For boards where the power of appointment lies with the Minister, some appointments must be noted by Cabinet before being made by the Minister.

This list shows which boards need to come to Cabinet. If a board is not listed below, appointments to it are not required to go to Cabinet or Executive Council. However, the responsible minister may still ask Cabinet to note an appointment if he or she sees a reason to do so.

The [Cabinet Submission - Appointments](#) template should be used for all appointments that are to be considered by Cabinet regardless of whether they are for approval or noting.
