### **Freedom of information application**

I refer to your request received by the Department of the Premier and Cabinet (DPC) seeking access under section 13 of the *Freedom of Information Act 1991* (the Act) to:

*All documents and records including but not limited to financial documents (including receipts), bank statements and credit card statements regarding access to foreign currency for ministerial travel for the period 14 March 2014 to 17 March 2018*

Under the Act, an agency has 30 days to respond to a freedom of information request. As DPC did not respond to your request within the time frame required, the department is deemed to have refused you access to all documents relevant to your application. However, I have determined to process the request as if the statutory time frame had been met.

In consultation with your office, it was agreed DPC would provide you with a system generated report detailing all relevant Ministerial staff transactions for the period requested. I have determined to release this document to you in full.
